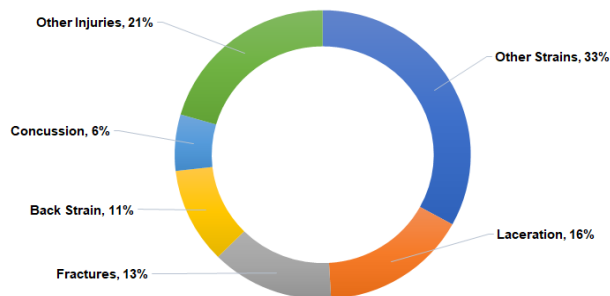

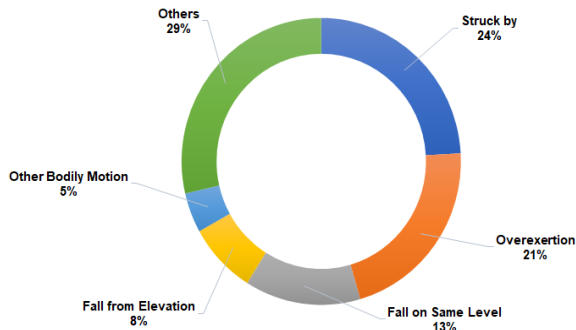

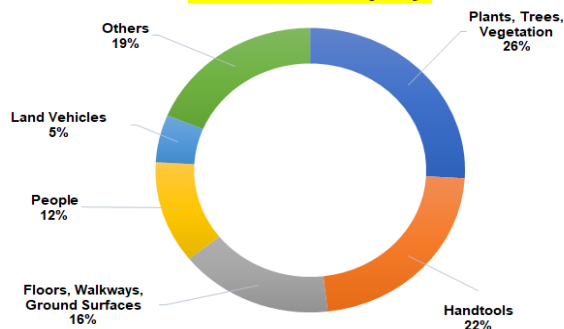
Nature of Injury



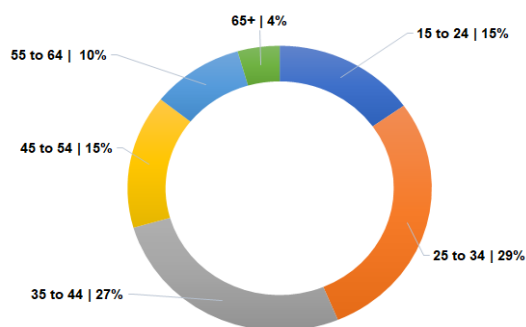
Mechanism of Injury



Source of Injury

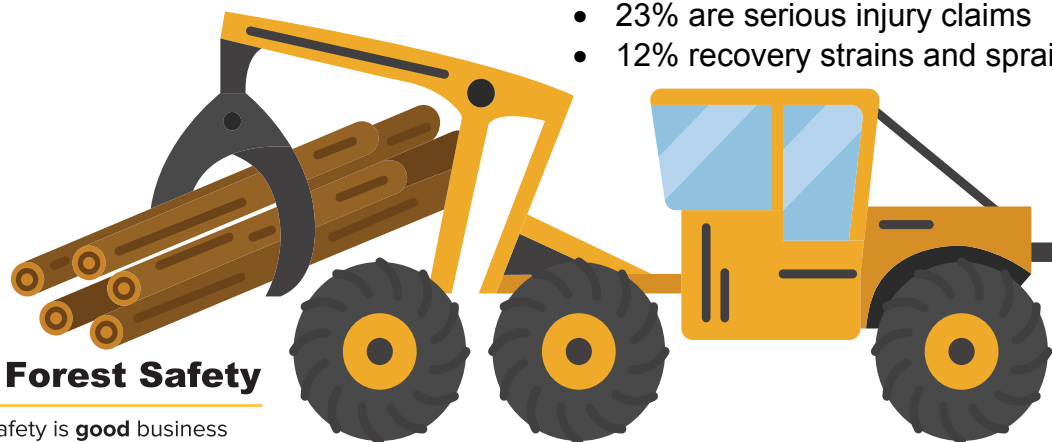


Worker Age at Injury

- 12% recovery strains and sprains

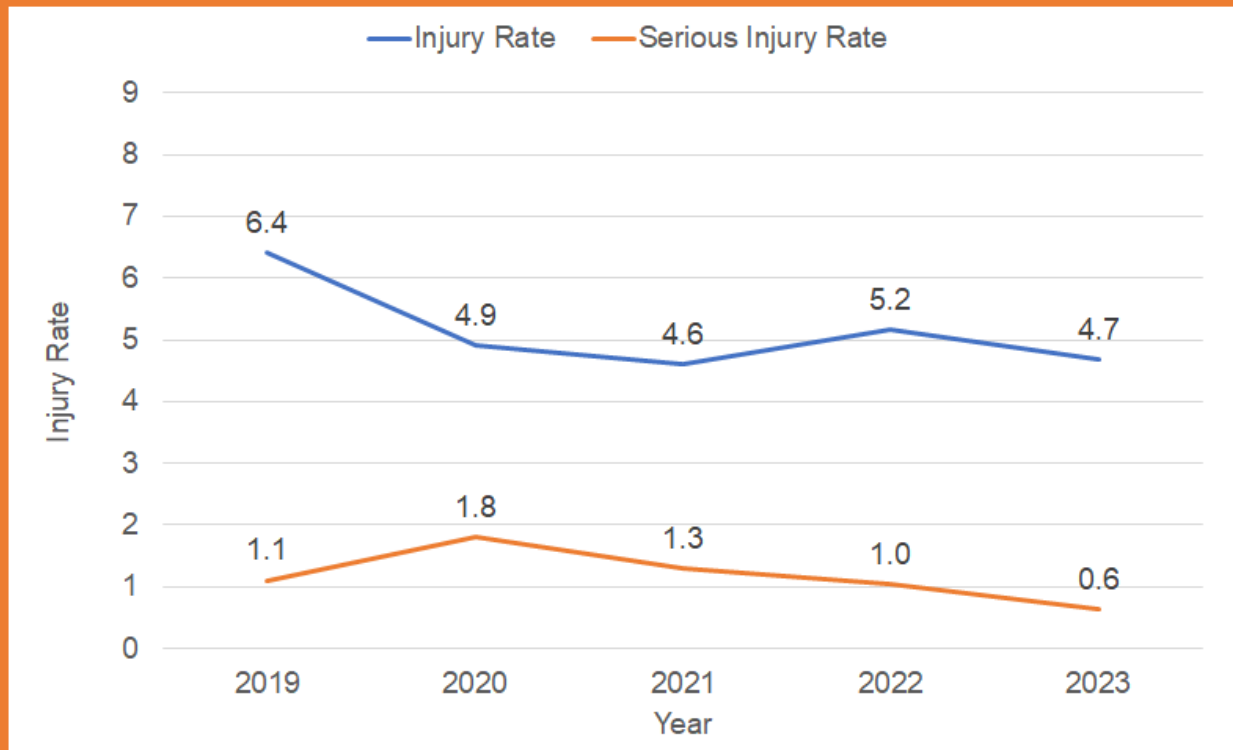
