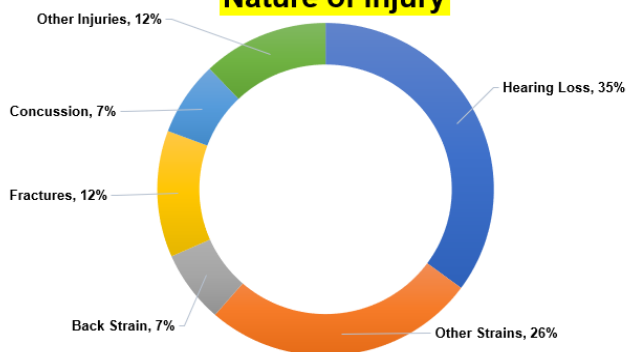

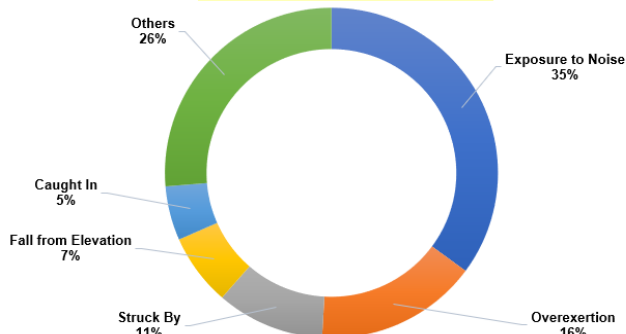

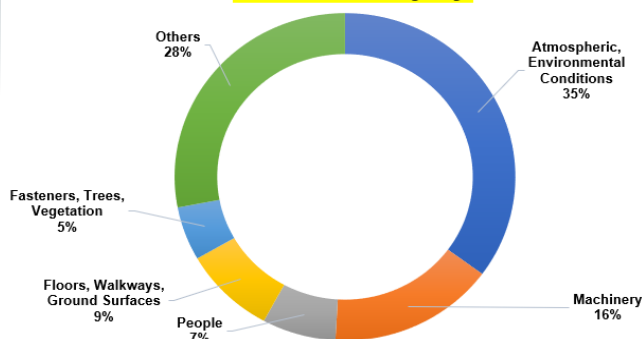
**Nature of Injury**



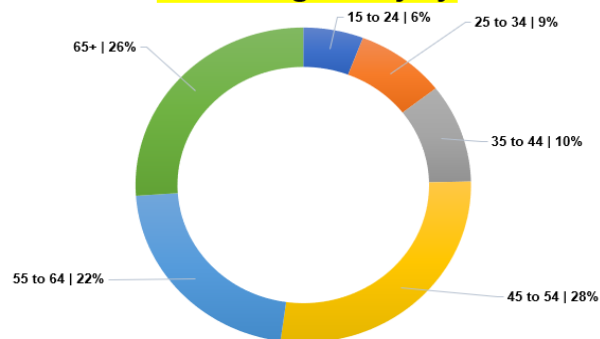
**Mechanism of Injury**



**Source of Injury**

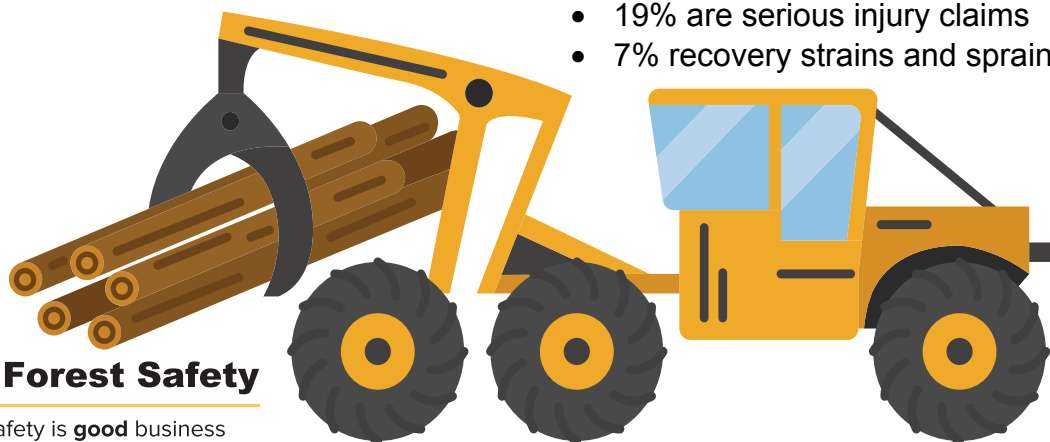

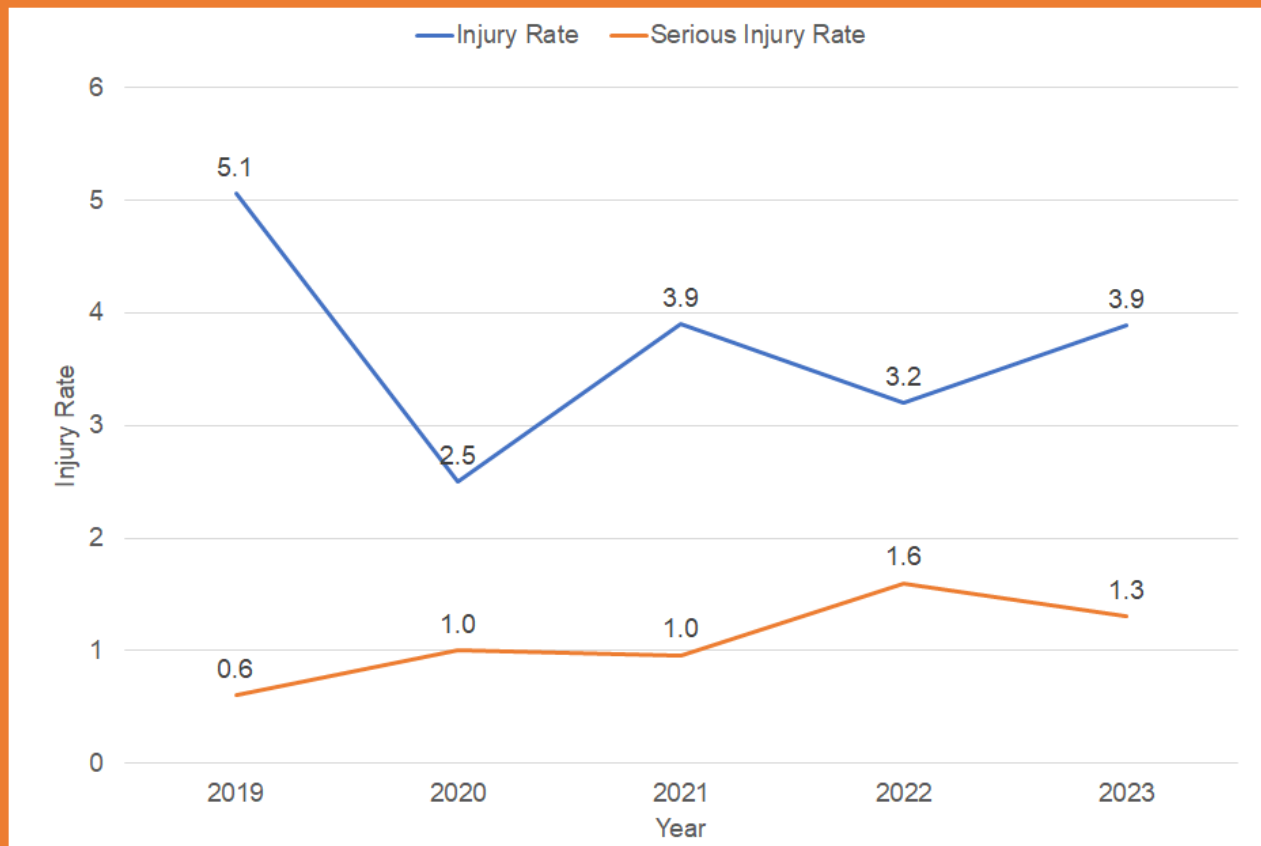
