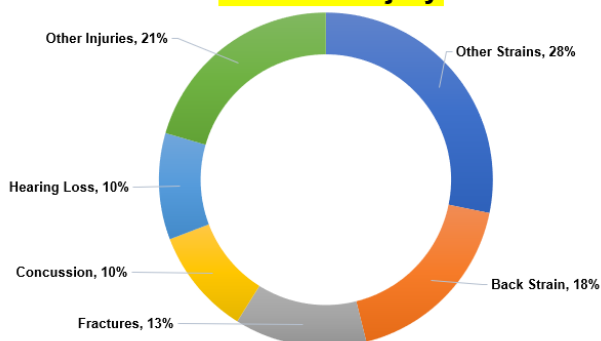

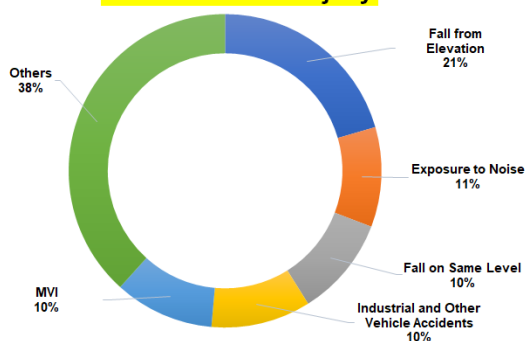

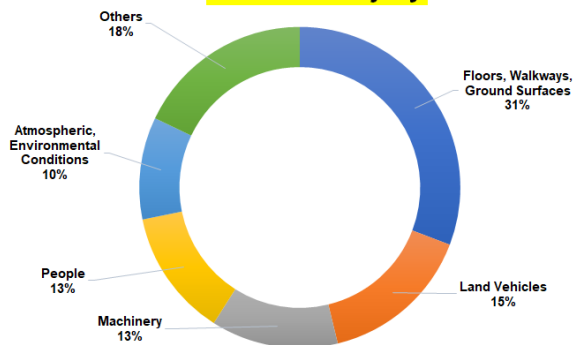
Nature of Injury



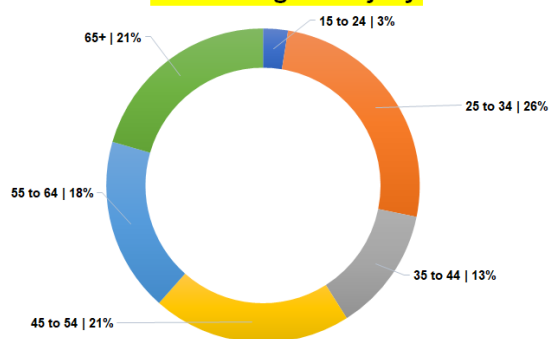
Mechanism of Injury



Source of Injury

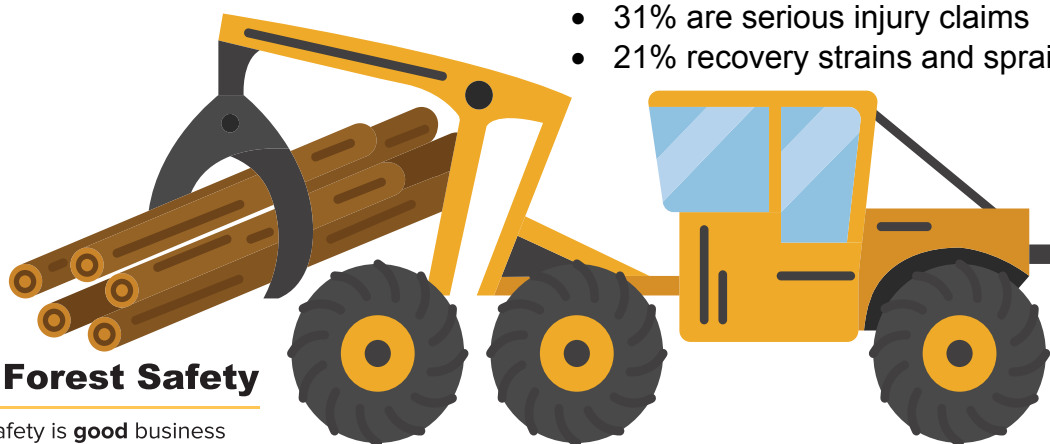


Worker age at Injury

- 21% recovery strains and sprains

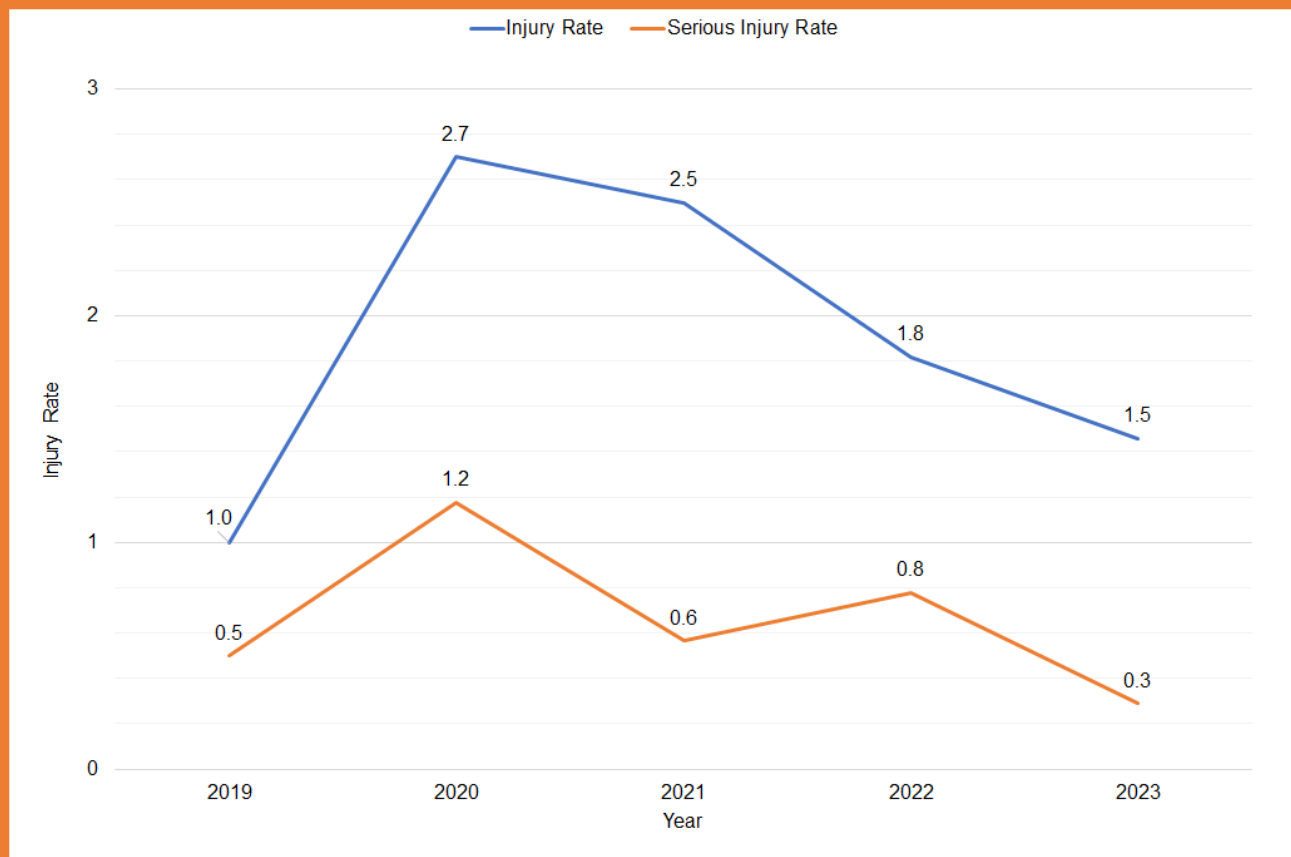
